19-143: Moved by Mix seconded by King to approve the school board meeting agenda as presented. All voted aye. Motion carried.

19-144: Moved by King seconded by Lundquist to amend the 2019-2020 contract of Lauren E. Antonen to add lead teacher at \$3,746.25. All voted aye. Motion carried.
